TERMS OF REFERENCE FOR PROVISION OF MAINTAINANCE SERVICES FOR WIDE AREA NETWORK INFRASTRUCTURE





Overall Objective of the Contract

The main objective of the contract is to provide network operations maintenance services to the Long-Distance Air Fibre Wi-Fi Backbone Wide Area Network. This entails equipment maintenance in 28 high sites and 113 last mile sites connected to the backhaul under Ministry of Health.

The objectives of the maintenance plan are to:

1. Maximize equipment performance by keeping equipment running safely for as long as possible, without equipment deteriorating or having unplanned outage.
2. Have improved infrastructure throughput and response time.
3. Reduce unplanned equipment downtime and improve overall equipment performance.
4. Reduce repair costs.
5. More efficient use of manpower and other resources because maintenance work, parts inventory, tools and financial costs, can be spread more evenly throughout the year.
6. Improved plan for spare parts use and ordering.

Scope of Work

NERCHA seeks to engage a vendor who will maintain the network and ensure it is resilient and highly available.

Below is the scope of work;

- Monitor battery power
- Monitor battery charging rate
- Check earthing
- Replacing damaged Ethernet cables
- Bush clearance to ensure clear Line of Sight (LOS)
- Replace damaged devices and reconfiguration
- Realigning devices to control signal noise and improve link capacity
- Device relocation
- Maintenance of equipment

Validity of EOI

EOI will be valid for 60 days from the last day of submissions.

Evaluation Criteria

When evaluating the EOI, the following criteria shall be used:

- Technical capacity relevant to service – 50%
- Experience in conducting similar works; range and depth of experience with similar projects – 50%

Withdrawal, Substitution, and Modification of Submissions

A Service Provider may withdraw, substitute, or modify its Bid after it has been submitted by sending a written notice, duly signed by an authorized representative, and shall include a copy of the authorization (the power of attorney). The corresponding substitution or modification of the bid must accompany the respective written notice. All notices must be





- (a) prepared and submitted in sealed envelopes and shall be clearly marked "WITHDRAWAL," "SUBSTITUTION," or "MODIFICATION;" and
- (b) received by the Purchaser prior to the deadline prescribed for submission of EOI.
- (c) Submissions requested to be withdrawn shall be returned unopened to the Bidders.

No bid may be withdrawn, substituted, or modified in the interval between the deadline for submission of bids and the expiration of the period of bid validity specified in the EOI.
